Equity

A Power Point presentation focused on the history of racism and shared language was shared. Comments from Council Members:

- Dr. Robinson asked for clarification on the equity graphic. She recognized that she had not seen this slide before and that this is a new take on this slide. It is showing that the fence is lower for one. In this slide we have an equal visual field and we are calling it equality. Everybody is given the same thing but everybody doesn't have the same black/brown experiences. It was agreed that we will look back to where we got this graphic from and will share clarification.
- Dr. Robinson encouraged everyone to get the book "Without Sanctuary".
- Dr. Robinson asked to remember that Black history started long before enslavement. History of Africans in America should be acknowledged as a great African civilization that existed long before this country was discovered.
- Chair Bean stated that none of these facts sit well. It is an unfortunate reality that we need to live and deal with.
- Dr. Robinson asked everyone to think about the question ... are we repeating the cycle?
- Chair Bean stated that it resonated with him how slavery started in this country and what it evolved to and how it became so blatantly targeted around race and how that continued post reconstruction. From federal laws and agencies that were intended to provide opportunities and explicitly carved out those opportunities to Black Americans. It shows complete injustice.
- Elisa Cramer thanked staff for putting this together. She shared that these are difficult times and appreciated having information that she can share with others. She asked that we take a look at our own personal journeys and look at where we can continue to make improvement to the systems that we work in. She thanked Dr. Robinson for her courage in approaching these issues, too.
- Jose Luis Rodriguez thanked everyone for the presentation and for their hard work on it.
- Keith Oswald thanked everyone for sharing this presentation. We should be strategic about deconstructing practices across sectors and suggested that we share best practices on how others are doing it. Lisa Williams-Taylor stated that there is work that is being led by the Department of Children and Families focused on looking at racism within the child welfare system, as well as work that the School District is also doing. Typically we look at data and see disparities but we need to look at the "why" from an institutional lens.
- Dr. Robinson thanked everyone and suggested that different entities can take different areas to offer a deep dive. Lisa Williams-Taylor shared that we have been working on planning additional workshops focused on equity for next year. In December we will be having a workshop on why it is important to lead with race.

#### **SUMMARY:**

The Council's procurement procedures require that we competitively procure for insurance broker services every five years. The contract with our current broker, Beacon Group, Inc. expires as of January 3, 2021.

On August 25, 2020, CSC released an RFP for Broker of Record for Property, Casualty and Related Insurances. Four agencies submitted proposals. Each proposer responded to the same set of questions which were assigned a point value, based on a 100 point scale. The four person review team reviewed and scored the proposals individually and jointly. This was followed by a virtual interview of the two highest scoring brokers.

Additionally, as the Council was advised at our August meeting in the CEO Report, this was our "pilot" effort to procure with an equity lens. To that end, adjustments were made to the minimum requirements and a 10 point scoring preference was included. We expanded our advertising outreach to Hispanic and Black chambers of commerce, additional newspapers and local radio stations. No minority business enterprises submitted a proposal.

The review team completed its deliberations on October 28, 2020 and recommends that CSC enter into a 5 year agreement with The Beacon Group, Inc. effective January 4, 2021- January 3, 2026. The agreement will be commission-based. Commissions generally range between 10-20 percent per line of coverage.

#### **FISCAL IMPACT:**

The FY 20-21 budget, approved by the Council on September 24, 2020, included expenses of \$208,235 for non-benefit related insurance premiums.

#### **RECOMMENDATION:**

I recommend the Council approve Resolution # 20-034 authorizing the Chief Executive Officer to enter into the necessary agreements with Beacon Group, Inc. to serve as our agent/broker of record for CSC's property, casualty and related insurances for the period January 4, 2021-January 3, 2026, subject to the Council's annual budget and TRIM process.

WHEREAS, the review team completed its deliberations on October 28, 2020 and recommends that CSC enter into a five year agreement with The Beacon Group, Inc. effective January 4, 2021-January 3, 2026; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE CHILDREN'S SERVICES COUNCIL OF PALM BEACH COUNTY, that the Council authorizes the Chief Executive Officer to enter into the necessary agreement with Beacon Group, Inc. to serve as our agent/broker of record for CSC's property, casualty and related insurances for the period January 4, 2021 through January 3, 2026, subject to the Council's annual budget and TRIM process.

## **PROCLAMATION**

# Declaring the Month of January 2021 As Mentoring Awareness Month

WHEREAS, mentoring measurably improves the lives of individuals and families in Palm Beach County with strong impact on rates of school attendance, avoidance of substance abuse and reductions in violence; and

**WHEREAS**, youth engaged in an active mentoring relationship are 55 percent more likely to be enrolled in college, and 52 percent less likely to skip a day of school, according to the National Mentoring Partnership; and

**WHEREAS**, youth who are mentored are 46 percent less likely to start using drugs and 27 percent less likely to start drinking, according to the Partnership; and

WHEREAS, about 5,000 children are assigned to mentors in Palm Beach County through the United Way Mentor Center in the past fiscal year, including 1,767 children matched with mentors through 23 programs funded by Children's Services Council; and

**WHEREAS**, the total number of children assigned to mentors through the Center is the highest in its history; and

WHEREAS, of the 1,767 matches in CSC-funded programs, 951 are girls and 695 are boys 9 are nonbinary and 10 are transgender with the rest unknown; and in addition, 1,020 of them are Black, 313 are white, 318 are other (including mixed races), with the rest unknown; and

**WHEREAS**, The Mentor Center also serves as the anchor of the Palm Beach County Mentor Network, a professional group of 50 formal mentor programs – eight more than last year – working together to elevate mentoring in the community; and

**WHEREAS**, The Mentor Center is the only Florida affiliate of the National Mentoring Partnership and is one of just three nationally that awards grants and monitors subcontracts; and

WHEREAS, the National Mentoring Partnership also developed two virtual mentoring platforms used in Palm Beach County so mentoring continued throughout the pandemic, and online recruitment focused more on social media and targeted emails to bring mentors and mentees together at virtual recruitment events; and

Resolution # 20-033 Authorizing Changes to the Council Bylaws

**CSC STAFF:** Debra Gotlib, General Counsel and Chief of Legislative Affairs

**SUMMARY:** 

At our meeting on October 22, 2020 Council members discussed a possible change to the Bylaws that would prohibit abstention from voting on any measure coming before the Council, with certain exceptions. While public officers of most governmental entities are prohibited by statute from abstaining from voting, special districts are not subject to the voting requirement section of the Florida Government in the Sunshine Law (FS 286.012)

After some discussion about the impact of this change and the Council's interest in transparency, as public officers, the Council requested that proposed Bylaws be presented to the Council for consideration.

One other change has been proposed to accommodate our move from paper to electronic record retention. Below is Article III E. - Minutes and Article IV A.- Voting and Quorum, with the proposed changes.

This change must be approved by a majority of the entire Council per Article IV of the Bylaws.

- Article III. E. <u>Minutes</u>: Minutes of each meeting of the Council shall be accurately taken, preserved and provided to members at or before the next regular meeting.
- Minutes, recording The typed minutes of each meeting shall be reviewed, corrected if necessary, and approved at the next regular meeting; provided, that this action may be taken at an intervening emergency meeting if the board desires. The minutes shall be signed by the Secretary (or in the absence of the Secretary, one of the other officers) and Chief Executive Officer after approval and shall be retained as a permanent kept as a public record in a permanent bound book in the Council's office.
- 2. <u>Minutes, contents</u> The minutes shall show the vote of each member present on all matters on which the Council takes action. It shall be the duty of each member to see to it that both the matter and his/her vote thereon are properly recorded in the minutes. Unless otherwise shown by the minutes, it shall be presumed that the vote of each member present supported any action taken by the board.

## Article IV. Voting and Quorum

A. Each member shall have one vote which may only be exercised by the member not by proxy or by designee. Council members may not abstain from voting on any matter that comes before the Council unless 1) there is or appears to be a possible conflict of interest under Section 112 Florida Statutes (Florida Code of Ethics) 2) the juvenile judge determines that a matter coming before the Council may result in a conflict relating to his/her duties as a juvenile judge 3) or unless prohibited by statute. Members that abstain due to a conflict under Section 112 will comply with the disclosure provisions of Sections 112.

## RESOLUTION OF THE CHILDREN'S SERVICES COUNCIL OF PALM BEACH COUNTY AUTHORIZING CHANGES TO THE COUNCIL BYLAWS

The minutes shall be signed by the Secretary (or in the absence of the Secretary, one of the other officers) and Chief Executive Officer after approval and shall be <u>retained as a permanent kept as a public record in a permanent bound book in the Council's office.</u>
- Minutes, contents The minutes shall show the vote of each member present on all matters on which the Council takes action. It shall be the duty of each member to see to it that both the matter and his/her vote thereon are properly recorded in the minutes. Unless otherwise shown by the minutes, it shall be presumed that the vote of each member present supported any action taken by the board.

Addition of a Payback Provision to the Tuition Reimbursement Policy

**CSC STAFF:** Shay Tozzi, Director of Human Resources and Operations

**SUMMARY:** 

On October 22, 2020 the Human Resources Committee considered a change to the Tuition Reimbursement Policy, a part of the CSC Employee Handbook that is reviewed by the Council annually.

At present, CSC does not require staff who receive tuition reimbursement to commit to future employment with CSC.

The Committee considered the below information and had discussions regarding a change to the policy to require staff to payback some portion of tuition reimbursement should they leave CSC employ with 1-2 years of the most recent year's reimbursement.

As background for the Committee, CSC staff applied the Racial and Ethnic Equity Lens to the Tuition Reimbursement Policy and its usage. The table below outlines staff usage and demographics over the last five years:

In researching the Tuition Reimbursement payback provision, staff have found that while some agencies have this policy, it is generally not enforced. Given our organizational size, we understand that we are unable to provide a career path for all positions, which may lead to staff leaving to further their careers. With that said, we support the practice of providing tuition reimbursement to staff members who have expressed interest in continuing their formal education and have not required staff to pay back tuition reimbursement upon leaving.

Based on the reasons outlined above, staff recommended that the policy should not be changed at this time.

The Human Resources Committee members considered the above in its discussion and its fiduciary duty as Council members and recommends that the Council approve a change consistent with the attached, which will institute a payback provision.

#### **RECOMMENDATION:**

The Human Resources Committee recommends the Council approve the addition of a payback provision to the current Tuition Reimbursement Policy of the Employee Handbook, consistent with the attached draft policy.

## **Tuition Reimbursement Policy and Procedure**

#### **PURPOSE**

To encourage employee professional and personal development by providing financial assistance for completion of educational courses related to the work of CSC.

#### **SCOPE**

Reimbursement of registration, tuition, books, and laboratory fees will be covered in accordance with the parameters below.

### **POLICY REFERENCE**

CSC Employee Handbook/Personnel Policies - Section V

Employees requesting reimbursement will be informed of this procedure through the new employee orientation process and upon request. Full-time employees who have completed one (1) year of active service are eligible for this benefit. Additionally, part-time employees who have completed one (1) year of service are eligible to receive a pro-rated benefit based upon the number of hours worked. Employees should be aware that these benefits may be considered taxable income under IRS rules.

#### ADMINISTRATION/RESPONSIBILITY

The Tuition Reimbursement Committee is responsible for the administration of the Tuition Reimbursement program. Reimbursements will be the lesser of the actual tuition, books, and lab fees or a calendar year maximum of \$5,250 for full-time employees and pro-rated maximum will be determined for part-time employees based on hours worked. Reimbursement will be made for undergraduate courses with a passing grade of "C" and graduate courses with a grade of "B" or higher.

Non-degree and certification programs are subject to approval of the employee's immediate supervisor and are payable through Staff Development funds. The employee must submit a confirmation letter of completion for the course work noted below:

- Non-degree, vocational/technical education courses and programs.
- Professional certification directly related to the employee's position.

The Tuition Reimbursement Committee will be available for consultation on Tuition Reimbursement submissions. The Tuition Reimbursement Committee will consist of the Director of Human Resources and Operations, the Chief Operations Officer (COO), the Chief Financial Officer (CFO), and the Human Resources Technician.

#### PROCEDURE FOR TUITION REIMBURSEMENT

#### **Prior to Course Enrollment**

- Employees should submit the Application for Tuition Reimbursement form in CSCIS Events/Travel Module. The
  electronic form will be forwarded to the employee's Supervisor and the Director of Human Resources and
  Operations for approval. Electronic Tuition Reimbursement Application forms must be submitted in a timely
  manner to ensure proper review and approvals can be obtained prior to the beginning of the course. Except
  in extenuating circumstances, applications should be submitted prior to the commencement of the course.
- 2. Tuition Reimbursement Application approvals/declinations will be communicated via automated email. When necessary, the Tuition Reimbursement Committee will review the request and forward to the CEO for final decision.

### **Steps to Complete the Request**

- Employees must submit the electronic Tuition Reimbursement Request with the required paperwork within
  forty-five (45) days of the completion of the class/course. After completion of the course, the employee will
  receive an automated email to complete the Tuition Reimbursement Request (Please contact Human Resources
  if an email has not been received).
- 2. Employees must save all the required documentation for submittal in a Box Folder marked with their name (Example: Betty Smith Tuition Reimbursement) ensuring that Tuition Reimbursement Committee has appropriate rights to the folder. Documents required for approval are:
  - a. A copy of the document from the appropriate educational institution indicating successful completion of the course(s) for which the employee is seeking reimbursement.
  - b. A receipt from the educational institution indicating the actual costs paid for tuition.
  - c. Any other receipts for books, lab fees etc.
- 3. Employee will then submit the request for final approval by clicking the Modify button on the existing request, attaching the above documentation and clicking Submit button.
- 4. The Tuition Reimbursement Committee will:
  - a. Review and approve the documentation received.
  - b. Create a Purchase Order for tuition reimbursement in the amount approved.
  - c. Submit the approved Tuition Reimbursement Request to Accounting for final processing.
- 5. Reimbursement will be processed by the Accounting Department through the normal payable process and procedure.

#### PROCEDURAL REQUIREMENTS/RESTRICTIONS

- 1. In order to be eligible for reimbursement, courses must be taken at an accredited college or university.
- 2. Reimbursements will be made for registration, tuition, books, and lab fees only. Fees for tools, supplies, travel, meals, lodging, or other education-related costs are not eligible expenses under this procedure.
- 3. Reimbursements will not exceed the stated maximum.
- 4. Reimbursements will be made only courses considered job related or related to a promotional or transfer opportunity at CSC.
- 5. Classes will not be taken during the employee's regularly assigned work hours and the hours spent in class will not be counted as "time worked". Where class hours begin within one (1) hour of the end of the employee's regular workday, the employee may use pre-approved vacation, personal, compensatory, or leave without pay to attend classes upon approval from the supervisor.
- 6. Leaves of absence will not be allowed for educational pursuits as defined in this policy.

#### **PAYBACK PROVISIONS**

- 1. If the employee separates employment from the CSC within 12 months of receiving any reimbursement, the employee must pay back 100% of the last year of reimbursement.
- 2. If the employee separates employment with the CSC within 24 months of receiving any reimbursement, the employee must pay back 50% of the last year of reimbursement.

## **Tuition Reimbursement Agreement**

CSC has agreed, on the terms set forth in this Agreement, to financially reimburse Employee for tuition for an approved educational program. In exchange for CSC's financial assistance, Employee agrees to reimburse CSC either through work (by remaining employed with CSC for a specific time period as set forth in this Agreement) or by repayment (if Employee leaves before completing the agreed-upon service to CSC as provided in this Agreement).

*In consideration of payment of these expenses, you agree to the following:* 

If you separate employment with CSC after completion of the course and it is within 12 months of receiving any reimbursement, you must pay back 100% of monies received of the last year of reimbursement. If you separate employment with CSC after completion of the course and after completing one year (12 consecutive months) of active employment but prior to completing two years (24 consecutive months of active employment), you will refund 50% of the last year of reimbursement. For example, if you receive the maximum of \$5,250 for an educational course and work only 14 months after completion of the course, you will refund 50% of the \$5,250 or \$2,625.


If any action is brought to enforce any provision of this agreement by CSC you agree to pay all costs associated with the action as well as any costs of litigation, including all reasonable attorney fees.

This Tuition Reimbursement Agreement creates no contract of employment between you and CSC. You may terminate your employment with CSC at any time with or without cause, and CSC may terminate your employment at any time with or without cause.

By signing this Agreement, you agree that any tuition reimbursement repayment you owe to CSC will be deducted from your final paycheck.

Staff who are currently taking a course or have registered for, but not yet begun a course as of January 1, 2021 will not be subject to the payback provisions of this policy for that course. Staff who register for a course after January 1, 2021 are subject to the payback provisions.

## **Program Updates**

## **COVID-19 Relief and Recovery Funding Update**

### **Funding Update**

As in past local disasters, the funders in Palm Beach County have coordinated their relief and recovery efforts during the COVID-19 pandemic. A group of local foundations, the United Way, and CSC released a joint application in March. The Palm Beach County Coronavirus (COVID-19) Relief and Recovery funding process received more than **550 applications** from local nonprofit organizations requesting in excess of \$29 million in assistance. Collectively, the local participating funders have provided over **\$7 million** to the nonprofits.

To date, CSC has provided over **\$860,000** in COVID-19 Relief and Recovery funds to **55 organizations** using the common application process coordinated with a group of local funders. The majority of CSC's funding (\$587,100) has gone to organizations to distribute **food and other essential supplies**. CSC also funded \$280,605 to organizations who revised and/or expanded their **services** to address a need created by the pandemic.

### **New Application**

The funding application process has been paused and a revised application is likely to be released after the start of the new year. The funders are discussing what revisions are needed to the application. **CSC staff** recommends that we keep the same priorities/limitations to our **COVID-19** funding for this fiscal year.

CSC's priorities were set based on feedback from Council members at our March 19th meeting and the areas CSC would consider funding through the Coronavirus (COVID-19) Relief & Recovery application process included: (1) Food (2) other basic needs (though not shelter); and (3) direct services to children and families. After discussion with members, there was not consensus to fund shelter, health care, technology, or reimbursement for lost revenue at this time. Staff also recommended prioritizing CSC funding to first go to CSC funded agencies, then Great Ideas Initiative Recipients (current and past), and lastly, other child/family serving nonprofit organizations.

## **CenteringPregnancy® Receives National Recognition**

The Prenatal-to-3 Policy Impact Center at The University of Texas at Austin recently recognized group prenatal care as an effective practice. While group prenatal care may take different formats, one of the evidence-based models is CenteringPregnancy<sup>®</sup>. CenteringPregnancy<sup>®</sup> has been found to improve birth outcomes, supporting health parent-child interactions, and increasing prenatal behaviors that lead to positive life outcomes for children.

Since 2008, HMHB has been the only provider of CenteringPregnancy® in Palm Beach County and leads two of only six Centering programs in the State of Florida. Participants of the program are placed in groups of 8 to 12 women with similar gestational ages and meet throughout their pregnancy in a personal atmosphere

designed for learning and sharing – one that is impossible to replicate in a standard medical setting. With the onset of COVID-19, HMHB's Centering team quickly adjusted to social distancing standards and groups began meeting virtually to maintain the health and safety of the expecting moms and staff. Their dedication to ensuring women received a quality experience through the additional challenges faced was evident as the number of group prenatal sessions increased by 55% over the last fiscal year. Prenatal care is a successful strategy to improve maternal and child health outcomes.

Despite not having the in-person connection, the virtual groups were still beneficial. A recent participant said, "My experience in Healthy Mothers, Healthy Babies' Centering group has been wonderful. I have learned a lot about topics of great interest that were done in virtual sessions because of the COVID-19 pandemic, but although they were not in person they were still interesting. They offer tools so a pregnant woman can gain knowledge and techniques to care for the baby once he comes into the world. They reinforce the importance of breastfeeding not only for the baby but also for the mom to avoid certain diseases or malignant conditions. They did raffles of essential items and offered transportation! They offer exceptional follow-up during your gestation and also involve the husbands with surveys!! In summary, the attention is wonderful and I feel very happy to have been part of the group, which I recommend 100%."

## **Special Needs Update**

## Overview of Fiscal Years 2010-2011 through 2019-2020


The Special Needs Equipment Fund (implemented through United Way with funds from CSC) purchases durable medical equipment for children birth to age 17 with special needs who reside in Palm Beach County. The Fund is designed to purchase equipment that will enhance safety, mobility, communication (speech or hearing), vision, and/or be medically necessary. This is a fund of last resort intended to fill gaps in the current service system for equipment purchases; as such, applications are only accepted for children in need whose families have no other means to obtain the equipment. All applications must include a letter from a licensed professional verifying that the equipment requested is necessary for the child's well-being.

Over the past ten years, the Fund has purchased equipment for 426 children. CSC's investment of \$1,069,228.63 over the past ten years has allowed the Fund to purchase 464 items for these children, meeting their greatest needs and significantly enhancing the quality of their lives.

Data collected over the past ten years has been analyzed for trends and can be observed in the following graphs. Key highlights depicted include:


- Over the past ten years, on average, 48% of all equipment requested was for mobility. Requests for mobility equipment continue to exceed all other requests. In Fiscal Year 2019-2020, mobility accounted for 58.3% of items requested.
- Over the past ten years, 53% of all children served were under the age of 10, with 5-9 year olds representing 35%.

## Percentage of Expenditures by Quarter, Fiscal Years 2010-2011 through 2019-2020




Quarters are defined as: Q1 = October - December; Q2 = January - March; Q3 = April - June; Q4 = July - September

Mobility items include wheelchairs, strollers, gait trainers and walkers. Communication items include hearing aids, iPads and applications specific to communication. Safety items include transit brackets to secure wheelchairs, wandering bracelets, customized car seats, lifts for transferring, ramps, and SleepSafe beds. Other items include orthotic ears and cranial shaping helmet.

#### Fiscal Year 2019-2020 Client Stories

### Joshua's Story

Joshua is a 14 year old boy diagnosed with Cerebral Palsy. He is verbal and requires use of a wheelchair for mobility. Joshua experienced an accelerated growth spurt that resulted in multiple surgeries to his lower body. After coming home from the hospital, it became evident that Joshua had severely outgrown his bed. Joshua was using a standard hospital bed, which was difficult (and dangerous) because his parents had to manually lift him into and out of the bed multiple times throughout the day. The Special Needs Equipment Fund provided the funding needed to purchase an adjustable High/Low bed for Joshua. This bed has enhanced mobility features that allow Joshua to raise himself to a standing position or lower himself to a seated or laying position independently, eliminating the need for his parents to lift him. Joshua was thrilled to receive his new bed, and experienced a level of freedom he previously had not known. And he did not stop there - with his newfound independence he asked his parents to help him create a "teenager" room. He picked out a new color of paint for the walls, and he and his family had a great time updating his space.

## Yuli's Story

Yuli is a 13 year old girl diagnosed with spastic quadriplegia Cerebral Palsy. Yuli is completely dependent upon her mom - a single mother with another young child in the home - for mobility. Yuli's mom transfers her from her bed, wheelchair, bath chair, and stander multiple times throughout the day. Yuli's mom expressed increasing concern for Yuli's physical safety during these transfers because Yuli continues to grow in size and weight and mom has no help with these daily transfers. The Special Needs Equipment Fund was used to purchase a power operated lifter for the family. This was truly life changing as it enabled Yuli's mom to perform safer, faster, and more energy efficient transfers throughout the day. The Special Needs Equipment Fund was also used to purchase a manual wheelchair for Yuli. The power lifter and manual wheelchair have eliminated many of the barriers that prevented Yuli from being able to experience community outings. Yuli's mom is now able to transport her with ease, and they enjoy frequent trips to the park.

### Amelia's Story

Amelia is a four year old girl diagnosed with a neurological disorder called SYNGAP 1. This disorder causes developmental delays in speech and motor skills such as sitting, standing, and walking. It also causes seizures. Amelia is non-verbal but attempts sounds and gestures. She is very active and loves spending time outside with her family. Amelia lacks the strength and coordination required to ride a standard bike, but the Special Needs Equipment Fund provided Amelia with a three-wheeled adaptive tricycle. Amelia is able to pedal and steer the tricycle with minimal assistance, but the tricycle comes equipped with enhanced safety features and a handle at the back to allow her caregivers to help with propelling the bike and steering when she needs it. Having her own tricycle significantly enhanced Amelia's quality of life. In addition to the critical health benefits that come with regular exercise, riding this tricycle is Amelia's favorite activity and her face lights up each time she is able to go on a bike ride with her family.

## **Equity Update**

## **Core Team Update**

The Core Team met for the first time and selected a chair and co-chair. Marsha Guthrie will be serving as the Core Team's Chair and Kim Maxwell will be their co-chair.

They will continue meeting regularly and will be working on prioritizing and ensuring action items in the Racial and Ethnic Equity Plan are completed.

## **Racial Equity Institute Trainings**

We are currently negotiating with the Racial Equity Institute to bring several training sessions next year, including Latino Challenge and REI Trainings. There will be a Latino Challenge session that will be held locally on January 28 and 29. We are currently waiting for confirmation regarding the location and hours and will let the Council know all the details as soon as we have them available.

### We Can't Talk About That At Work!

In our continuous journey towards racial and ethnic equity, CSC staff read the book "We Can't Talk About That At Work!" by Mary-Frances Winter. We gathered for discussions, shared our thoughts and asked provoking questions that prompted dialogue.

We are providing a book to each one of our Council members in our efforts to have them join us in our journey.

## Growth in "Healthy, Safe, Strong Stories" on CSCPBC.org website

The Healthy, Safe, Strong Stories section on our website continues to highlight how our funded programs have been unwavering in their mission to keep Palm Beach County's children healthy, safe and strong. There are now 18 HSS Stories, featuring such programs as the Palm Beach County Food Bank, Healthy Families Florida, Safe Kids Palm Beach County, BRIDGES and the Healthy Beginnings Nurses. Two of the most recent stories are touching accounts involving the Early Learning Coalition of Palm Beach County. One story is about a grandmother who is an essential worker who received an ELC scholarship so her granddaughter, whom she is raising, could remain in child care. The second story is about how ELC and CSC

helped a preschool stay open. The preschool's director described her reaction when she got the e-mail from ELC that they would be paid based on enrollment and not attendance.

"I started crying," said Sara Giannetti, director of Central Baptist Preschool in West Palm Beach. "I started crying and called the owner. I told him and he could not believe it. It was just such a blessing. It helped us tremendously. Every month, we would get an e-mail updating us. Every time we got those e-mails I was in tears."
