SUMMARY:

At the Council meeting on January 30, 2020, staff informed the Council that the contract with the Institute for Child & Family Health (ICFH) would be terminated as of March 11, 2020 due to the revocation of ICFH's Nonprofits First accreditation. ICFH is currently one of three providers funded by the Council to provide the Child First program. The other two providers are Center for Child Counseling, Inc. and Families First of Palm Beach County. Both aforementioned agencies expressed an interest in serving the families in the ICFH service area and in absorbing the ICFH Child First program.

CSC staff developed a selection process, where both agencies had the opportunity to submit an application by February 5, 2020. Both the Center for Child Counseling, Inc., and Families First of Palm Beach County submitted an application for review, detailing their capacity to absorb the ICFH program, as well as their plans for a successful transition. The review process also considered the agencies' history of performance and their current standing with Nonprofits First and the Child First National Program Office. The selection process has been completed, and Center for Child Counseling, Inc. is the recommended agency to absorb the ICFH Child First program.

Staff is requesting authorization to amend the existing Child First contract with Center for Child Counseling, Inc. effective March 1, 2020 to increase the allocation from \$968,177 to \$1,588,177. Funds are included in the current year program strategy budget.

FISCAL IMPACT:

The total cost of the additional funding for this item will not exceed \$620,000 for the period March 1, 2020 through September 30, 2020. The funds to support this agenda item are already budgeted in the FY 19-20 program strategy budget. The estimated annualized allocation for FY 20-21 will not exceed \$2,000,000 and will be subject to the Council's annual budget and TRIM process.

Book for EveryChild" Campaign

SUMMARY:

In May, Children's Services Council will launch the ninth round of its early literacy campaign with book distribution events for approximately 90,500 children in grades pre-K through 5 in Palm Beach County School District traditional schools and public charter schools. The campaign, originally known as "My Happily Ever After Begins With Reading," was rebranded last year as "A Book for EveryChild." Our goal remains the same — to increase awareness among children and families of the importance of reading, emphasize summer reading, and make more books available to children to develop their reading skills.

With this agreement, the number of books distributed by CSC since the campaign started in 2013 will surpass 900,000. This year's books were selected with the input of a panel of Palm Beach County School District media specialists who weighed in on the books' diversity and popularity.

Scholastic, Inc. was selected based on its strong history since 2013 of diverse title selections, meeting all delivery deadlines, and providing value-added bonus books with each purchase. Scholastic, Inc. is an authorized vendor in State of Florida Department of Management Services portal for government vendors and contractors.

In addition, CSC will purchase 1,000 books to be distributed among the juvenile court judges of the 15th Judicial Court of Florida. The judges will use the books to build little libraries for the children who come through their courtroom. The juvenile operations manager at the Palm Beach County Courthouse offered input in the book selection.

To provide the time needed for packaging and delivery to individual schools by mid-May the order must be placed by March 1st. CSC will also update collateral material such as the EveryParent apps and website and social media, where appropriate, to focus the message on summer reading.

FISCAL IMPACT:

The total cost of funding this item for FY 2019-2020 is up to \$300,000, and the funds to support this agenda item are budgeted in the Program strategy budget in the Initiatives line item.



Program Updates

2019 Great Ideas Initiative Highlight

In 2016, CSC launched the Great Ideas Initiative to acknowledge and support nonprofits in the community doing great work to help youth grow up healthy, safe and strong. In 2019, CSC issued its fourth year of funding for GII to organizations with annual operating budget of less than \$1 million. Sixteen organizations were awarded up to \$35,000 each, for a total of \$489,008.92 in funding. Sunflower Creative Arts is one of the 16 awardees.



In 2018, Sunflower Creative Arts launched **Build** and Play After School to shine a light on the profound power of play. This free program invites children to create, invent, and build through child-directed creative play. The pop-up build and play labs take place in an open space, inside or outside, with an abundance of loose parts (cardboard, tape, fabric, paper tubes, art supplies, etc.) for children to enhance the 4Cs - creativity, communication, collaboration and critical thinking skills.

Through funding from the Great Ideas Initiative, the program has now expanded to four sites on

a weekly and after school basis. Locations include the Farmworkers Coordinating Council of Palm Beach in Lake Worth, Milagro Center, Achievement Center and Pine Grove Elementary School. Due to the success of the program, Milagro Center requested the inclusion of their middle school age children, expanding the program scope to children ages 3-14.

Between October 1 and November 12, 2019, eleven Build & Play sessions were held. Program counselors noticed an increase in collaboration, strong community skills, complex pretend play schemas and great variety among the types of things children were building on their own. Over the span of the funding, the program is scheduled to support more than 115 children between the four locations.

Data Science for Social Good Summer Project

Background

The Florida Data Science for Social Good (FL-DSSG) Program is a summer internship program that matches data science expertise with real-world problems. The FL-DSSG program works with community organizations who are trying to affect change in their communities and who have data management, analysis, and data visualization projects that have the potential to shift understanding around a community issue, influence planning, refine practices, or see efforts in supporting community initiatives more focused or renewed.

The goal of the FL-DSSG program, which is hosted at the University of North Florida (UNF) campus, is to promote data-informed approaches, and partners with community organizations to use these approaches to solve real world social problems in collaboration with aspiring data scientists.

The goal of the Children's Services Council of Palm Beach County's project, held between June and August 2019, was to evaluate the effectiveness of CSC-funded services, including combinations of services, on birth outcomes (for infants) and child outcomes (for children entering kindergarten).

Design

The longitudinal, independent study included Palm Beach County children born in 2012 and 2013 (N = 27,519 after data quality review) whose birth data were linked with PBC School District records of children completing the kindergarten readiness assessment in the fall of 2017 and 2018. This allowed the comparison of the effects of CSC program enrollment on birth outcomes and child kindergarten performance later in life.

Using the two-year cohort of births, the analysis was separated into two parts. The first part focused on the effects of CSC programming on influencing healthy birth outcomes, such as gestation periods and birth weights. The second part focused on the effects of CSC programming on influencing school readiness, broadly defined by iReady and STAR literacy assessment scores.

As part of the Council's mission, many mothers are referred to services and programs if they display risk characteristics evidenced by risk screening instruments. Initial analyses indicated a disproportionate number of women enrolled in CSC services who are at high risk for poor outcomes. Because this is a result of targeting and not a reflection of program impact, propensity score matching was conducted to correct for this bias and match women of similar risk profiles from the CSC to the non-CSC group. When correcting for this bias, evidence shows that programming is associated with more positive birth outcomes as well as increases in school readiness (child outcomes) for children who are most at risk.

Preliminary Findings

- CSC has succeeded in engaging and enrolling families who are most in need of services and supports to help their children thrive.
- Pregnant women at high risk for a poor birth outcome who enroll in CSC services experience over a half a pound increase in the baby's birthweight when compared to mothers with similar risk profiles who received no services.
- Children in families who enroll in CSC services within the first 5 years of life were more likely to increase their scores on measures of kindergarten readiness than children with similar risk profiles whose families did not enroll.
- Both the birth and kindergarten readiness outcome findings are irrespective of time or dosage. In other words, even a little bit is of benefit.
- Analyses for the cohort demonstrate that the birth outcome of a child is a vital contributor to the kindergarten readiness of the child.

What's Next?

Based on these preliminary findings, there is evidence that CSC investments are having a positive impact on PBC families participating in services. Further exploration is needed to understand the interaction between patterns of services and service combinations, levels and types of dosage and participant characteristics (e.g. risk, demographic, other).
