Prevention Partnerships for Children (PPC) currently has in effect for FY 2019-2020 a Memorandum of Agreement (MOA) with The School Board of Palm Beach County to fund a full time position for a Level 2 Specialist in Evaluation and Test Development. This position provides data and conducts statistical analyses and evaluations of educational programs funded by the Children's Services Council of Palm Beach County. The School Board has increased the position's salary for \$1,193.25 over the current budgeted amount of \$107,000. The current MOA will require an amendment to increase the amount by \$1,193.25.

FISCAL IMPACT:

The total increased cost of funding this item for FY 2019-20 will not exceed \$1,193.25 for a total annual cost of \$108,193.25. The funds to support this agenda item are budgeted in the PPC strategy budget line item.
