Judge Kroll made staff aware that Casey Foundation, under a Florida Youth Justice Commission, is looking at racial equity in juvenile justice. Judge Kroll stressed the importance of all the entities involved in racial equity working together. The CEO advised that she will look into this matter.

Vice Mayor Weiss asked if we track the families that we serve and their access to the internet. The Board of County Commissioners will be receiving money from the federal government and they would like to identify which communities are underserved with high speed internet. Lisa Williams-Taylor explained that we don't track this. We do have some idea from the BRIDGES families from when we partnered with the School District to provide dollars when the pandemic started.

Vice Mayor Weiss asked if there is a large picture of all the supports that go to a family. We only have data on the families that we serve and the services that we provide. Tanya Palmer advised that there is no overall matching for families. CSC does track referrals for services and for benefits.
