1. CALL TO ORDER

Chair Bean called the meeting to order at 5:01 pm. Roll call was taken

2. AGENDA

A motion by Goodman/Burke to adopt the agenda was approved by unanimous vote.

3. 2021-22 TENTATIVE BUDGET

A. Percent increase above rolled-back rate 0%

Debra Gotlib, General Counsel, stated that the proposed millage of .6233 which the Council tentatively approved on July 8, 2021, represents no increase of the rolled-back rate.

B. Presentation

Debra Heim, Chief Financial Officer provided a detailed overview of the 21-22 budget.

The CFO advised that the TRIM packet shows the proposed budget for FY 21/22 compared to the approved budget for the current FY 20/21. The proposed budget for 21-22 is \$40,228 lower than the proposed budget presented and tentatively approved by the Council on July 8, 2021.

The CFO reviewed the budget assumptions detailed in the TRIM packet.

The CFO stated that the proposed millage rate for Fiscal Year 21/22 is .6233, which is the rolledback rate. The proposed taxes to be levied for fiscal year 21/22 is \$133,216,049.

The total proposed budget for FY 21/22 is \$141,873,784. The proposed budget is increasing by 1.77% vs prior year primarily to accommodate an increase in program spending for natural cost drivers and expansions for currently funded programs.

The CFO further described the other Exhibits in the TRIM packet to the Council members.

Chair Bean advised that the Finance Committee is recommending tentative adoption by the Council of the proposed millage rate and the proposed FY 21-22 budget.

C. Public Comment on the tentative budget

There was public comment from one person reflecting opposition to the property tax.

D. Comments from the Council on the tentative budget

No comments or questions from the Council on the tentative budget.

4. 2021-22 TENTATIVE MILLAGE RATE - .6233

Chair Bean advised the Council that the tentative millage rate for 21-22 is .6233.

A. Public Comment on the millage rate

There were no comments from the public on the millage rate.

B. Comments from the Council on the millage rate

In response to a question by Council member Goodman, Chair Bean advised that the new millage rate, along with the fund balance and contingency fund would be adequate to meet any expanded need.

Chair Bean expressed appreciation for staff's fiscal prudence and being able to produce a sensible budget using the rolled-back millage rate.
